Maria Bigoni

Professor of Economics at the Department of Economics of the University of Bologna. She obtained a Ph.D. in Economics, Markets and Institutions from the IMT in Lucca. She was a visiting student at the Stockholm School of Economics, Tilburg University, Purdue University, and Chapman University. She has published in international journals such as «Econometrica», the «RAND Journal of Economics», the «Economic Journal», the «American Economic Journal - microeconomics», and the «Journal of Monetary Economics». Her main research interest is experimental economics. More recently, her research has focused also on the effects of economic inequality on cooperation, and on the evolution of preferences and pro-sociality among young children.

Stefania Bortolotti

Associate professor at the Department of Economics of the University of Bologna. She obtained a Ph.D. in Economics and Management from the University of Trento. She was a research fellow at the University of Bologna, the University of Cologne, and the Max Planck Institute in Bonn. She is interested in behavioural and experimental economics, and investigates topics such as cooperation, inequality, human capital, and algorithmic assignment. Her work has been published in international journals such as «Review of Economics and Statistics», «Economic Journal», «Games and Economic Behaviour», «European Economic Review», and «Journal of Money Credit & Banking».

Giuseppe Roberto Burgio

Former Full professor of Paediatrics at the University of Pavia, he was Director of the paediatric clinic at the University of Perugia from 1962 to 1965, in 1966 he took over as Director of paediatrics at the San Matteo Hospital in Pavia. In the twenty-four years of his directorship (1966-1989), he gave an extraordinary impulse to the paediatric clinic's activities

with the organisation, among other things, in 1976, alongside the in-patient wards, of a day-hospital type of admission system where children underwent clinical-diagnostic examinations in a short time with optimisation of services. He was president of the Italian Society of Paediatrics and is the author of a large number of scientific publications, including international ones. Thomas Casadei

Full Professor of Philosophy of Law at the Department of Law of the University of Modena and Reggio Emilia – Unimore, he is Director of the CRID – Interdepartmental Research Center on Discrimination and vulnerability (www.unimore.it), member of the “Red Iberoamericana de Investigación sobre Formas Contemporaneas de Esclavitud y Derechos Humanos” and is part of the Research group.MI (Univ. of Bologna). His research interests, in recent years, have focused on human rights and their violations, starting from the different forms of discrimination, racism, contemporary trafficking and slavery, women’s rights, and institutional practices of social inclusion.

Paolo Marino Cattorini

Former Full professor of Clinical Bioethics at the University of Insubria in Varese, he is a physician and philosopher specialising in clinical psychology.
